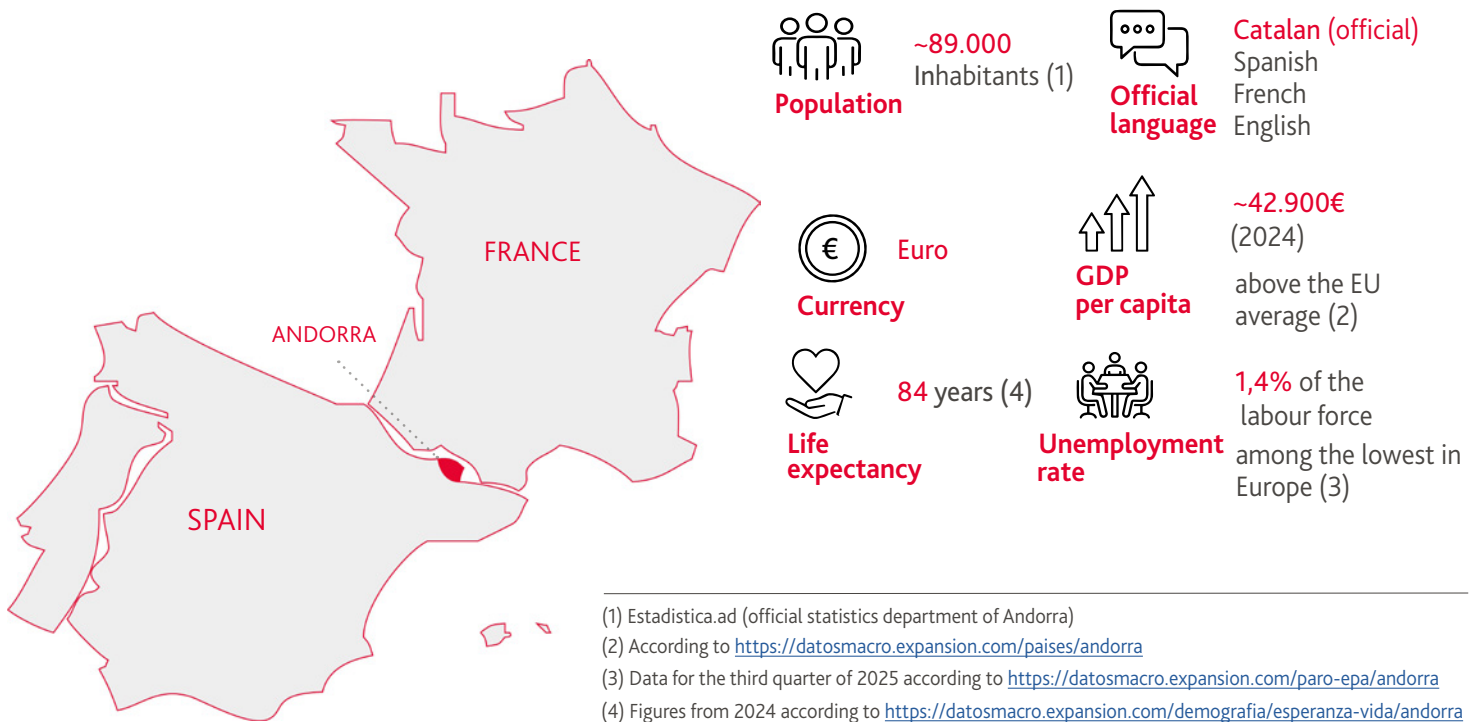

- A maximum income tax rate of 10%
- A 10% corporate income tax
- No wealth tax
- No inheritance or gift tax
- A VAT (IGI) with a general rate of 4.5%

REQUIREMENTS TO INVEST IN ANDORRA

TYPES OF RESIDENCY:

Active residence

- Employment contract (for employees) or incorporation of a company (for self-employed individuals)
- Non-refundable government contribution (only if self-employed)
- Registration with CASS (Andorran Social Security)
- Compliance with effective presence requirements (183 per year)

- ▶ For individuals who work in Andorra.

Passive residence

- Minimum investment in Andorran assets (real estate or financial assets)
- Non-refundable government contribution
- Private health insurance
- Minimum annual stay in the country (90 per year)

- ▶ For investors or individuals with sufficient means (not carrying out profit-making activities in Andorra).
- ▶ For professionals with international projects or scientific, sporting, or cultural interests.

Residency for Digital Nomads & Entrepreneurs

- Prior approval from the Ministry of Economy
- No non-refundable government contribution or deposit required
- Private health insurance
- Minimum annual stay in the country (90 per year)

- ▶ For remote workers, entrepreneurs and online content creators.

RESIDENCY REQUIREMENTS:

- Clean criminal record
- Proof of sufficient economic means
- Medical insurance
- Owned or rented housing
- Required administrative documentation

The process involves coordination across tax and administrative areas.
